The Blyth Academy Sixth Form -Student Agreement

I (student) agree to:

- Follow the Academy **business wear policy**.
- **Attend** the Academy every day and every registration, lesson, additional session and enrichment event **on time**;

- Contact a member of the Sixth Form team (or SLT if they are unavailable) if I need to leave the site during the Academy day (other than at lunchtime).
- Ensure any **part time work** does not conflict with studies, committing to no more than 12 hours per week of part time work. This includes being available to attend additional sessions outside lessons one to six;
- Be a **positive role model** for other students in the Academy;
- **Attend any additional sessions** reasonably requested by staff, including before and after Academy time;
- Make effective use of **study periods** and appropriate use **of study areas**;
- **Be organised**, using a Sixth Form planner and/or other method, **organise work** carefully and in line with staff guidance;
- Strive to become an **independent, reflective learner**;
- **Be positive, act on advice, work hard, aspire and participate**;
- **Complete home learning** regularly and meet deadline requirements;
- **Be fully involved** in the enrichment programme and the Academy community, supporting Academy events;
- Inform the Academy when I am required to take prescribed medication;
- Use social media in an appropriate manner.
